1. Overview

PLEASE CLOSE THE BROWSER WINDOW IN THE EVENT YOU DO NOT AGREE WITH THE TERMS AND CONDITIONS SET OUT HEREIN. FOR THE PURPOSES OF THIS TERMS AND CONDITIONS, "WE", "OURS" AND "US" SHALL MEAN THE Math Blackboard. "YOU" AND "YOURS" MEANS A PARENT OR GUARDIAN WHO PAYS FOR THE SERVICES OF A STUDENT UNDER THE AGE OF 18 AS WELL AS THE STUDENT WHO ACCESSES OR USES THE SERVICES. "SERVICES" MEANS ANY ONE OF THE PROGRAMS OF SERVICE OFFERED BY THE MATH Blackboard, AS OUTLINED IN THE "Services" SECTION BELOW. We reserve the right to make changes to these Terms and Conditions at any time without prior notice. Any such modifications will become effective immediately upon posting to the site and your continued use of the site and services constitutes your agreement to such modifications. You agree to periodically review the current version of these Terms as posted on the site. 2. Privacy Policy

We are concerned about your and our users privacy while accessing the site and using the Services. Please review our Privacy Policy to understand our practices.

3. Services

Through our services, we enable users to connect with a math tutor who provides instruction, tutoring, and learning services through the use of interactive technologies. The services include one-on-one live, interactive, tutoring sessions; live, interactive group math study sessions; and homework help through email communication. Email support is provided following one-on-one interactive tutoring sessions.

The live, interactive tutoring sessions take place using one of several communication options (telephone conferencing, live audio connection through the internet classroom space, Skype, or other similar applications) and an interactive whiteboard on which we will work together.

The Homework Help service is provided through email communication. For submissions received before 9 PM (CDT), you will receive a reply before the start of the next business day (8 AM CDT). For submissions received after 9 PM (CDT), you will receive a reply by 12 PM (CDT) of the next business day. The reply will

consist of a written narrative or step-by-step of the solutions, and worked out mathematical notations in a jpg, pdf, or screen shot file. Homework Help queries must be sent to <u>homeworkhelp@mathblackboard.com</u>. Your queries must include your name, telephone number, email, and the written homework problem or problems on which you are seeking help.

You are solely responsible for all service, telephone, internet, and/or other fees and costs associated with your access to and use of the Services and for obtaining and maintaining all telephone, computer hardware, and other equipment required for such access and use. In order for each live, interactive tutoring session to operate for the entire time for which you have signed up (60 minute session or 90 minute session), it is your sole responsibility to have your equipment set up and ready to receive information and the live connections from us. Additionally, if there is specific information or problem sets that you would like to submit to our tutor prior to your session, you are responsible for sending images or information regarding your math goals at least 15 minutes in advance of the start of your session in order that you will receive a full hour of live tutoring interaction. 4. Hours of Availability and Scheduling

We provide services throughout the day and evening hours, seven days a week. It is in your best interest to schedule live, interactive sessions well in advance in order to secure a time that works well with your schedule. When you have secured a time frame for a tutoring session, you are guaranteed that such time is securely set aside for you. Short notice or last minute scheduling of a session will be allowed if the requested time frame is available.

5. Technology

We attempt to ensure stability and availability of all technologies used by us. In the event of technology failure on the part of us so that a live, interactive session cannot take place, you will be given one of the following options: 1) be refunded the full cost value of the session, 2) be given opportunity to reschedule the session to another time, or 3) continue with the scheduled session using telephone conference.

You are solely responsible for all service, telephone and/or other fees and costs associated with your access to and use of the services; and you are solely responsible for obtaining and maintaining all telephone, computer hardware, internet connections, and other equipment required for access and use of our services. If you are unable to connect for a scheduled live, interactive session due to technology failure, you will be given one of the following options: 1) reschedule, with no penalty, to another available time that takes place within two days of the original session, 2) cancel the session and incur the penalty for a cancellation made in less than 24 hours in advance, or 3) continue with the scheduled session using telephone conference.

6. Cancellation and Refunds Policy:

If you need to cancel a scheduled session(s), you will receive a full refund if cancellation is received at least 24 hours in advance of the start of the session. Cancellation notice is to be sent to <u>ruth@mathblackboard.com</u> OR by texting to 218-310-1940. You must include your name and the time of the scheduled session that you are cancelling in your message.

A refund of 50% of the amount of the scheduled session is given if cancellation for a scheduled session is made less than 24 hours in advance.

If you have purchased a 10-hour package tutoring session and you cancel remaining sessions before all ten are used, you will be refunded the amount that would remain had the used sessions been charged at the higher rate of single sessions.

If you have a balance remaining in your account and decide to no longer receive tutoring services from us, any refunds due to you will be issued by a check from our business office within a month that you have called us with notification that you will no longer be using our services. Please note that for security reasons, we can process refund requests only by phone. You must call us at 218-310-1940 to inform us that you will no longer be receiving our services and would like any remaining balance refunded to you.

7. Payments

Payments are to be made before service is given. When you select an online tutoring plan or service and make payment online, we immediately charge your credit card or debit card and put into your account the amount of money paid.
